November 2025 POLICING REPORT

The following information is provided as the November 2025 Fort St John Detachment update on crime statistics, police activity, and new developments within the detachment operations and administration.

DETACHMENT RESOURCE REPORTING

For the month of November 2025, the detachment operated with 5 x SOFT (temporary) vacancy and 3 hard vacancies which include:

- 3 members are off duty sick, 1 member on Parental leave, 1 member on administrative leave.
- 1 Serious Crime Constable position is vacant; 1 position is vacant in Municipal Traffic, and 1 is vacant in General Duty.
- 1 new member is expected to arrive from Depot at the end of January 2026.
- 1 experienced member is expected to arrive February 2026.

CRIME TREND REPORTING

Over the period from January 1st, 2025, to the end of November 2025, there were a total of 10,793 calls for service. This is DOWN from 11,676 calls for service when compared to the same period in 2024, or a decrease of approximately 7.6%. Of those 10,793 files, 8,522 of the calls for service were within the City of Fort St John and 2,271 calls for service were within the rural surrounding area.

This month again is seeing a downward trend in property crime against vehicles. Theft of Vehicle over/under \$5000 went from 8 reported events to 6 in total. Theft from Motor Vehicle over/under \$5000, went from 14 to 6 incidents reported. Though Break and Enters to Business and residences have shown an uptick, from 6 reported offences to 14. 2 of the 4 reported business break and enters were to outside yards and sea cans. In

reviewing the residential break in files a few were evicted tenants returning to their rental. Shoplifting saw a reduction in reports also from 15 incidents to 13.

HIGHLIGHTS

Our General Duty and Municipal Traffic unit have been busy this month with an increase in collisions within the city limits, 27 reported incidents in October to 38 reported incidents in November. An increase in Mental Health associated calls for service has increased from 15 calls to 18 calls this month.

The Uniformed Gang Enforcement Team (UGET), supported by our Fort St John Street Enforcement Team (SET), deployed throughout the city and area for 10 days in November which resulted in a significant suppression and displacement in the gun and drug related violence. A highlight of the enforcement revealed 18 arrests, 4 firearms seized, and 19 possessions of drug (trafficking/possession) investigations amongst other enforcement action.
