I, Ron Laufer, of Vancouver, British Columbia, DO SOLEMNLY DECLARE THAT:

1. I was personally responsible for the conduct of Blueberry River Council Election held on January 12, 2026 (the "election day") in accordance with the Blueberry River Custom Election By-law, 2017;
2. A copy of the Notice of Nomination Meeting is attached as Exhibit "A" to this Declaration;
3. A copy of the Nomination Form is attached as Exhibit "B" to this Declaration;
4. In accordance with the Blueberry River Custom Election By-law, 2017, I publicly posted the documents listed in sections 2 and 3 of this Declaration and delivered copies of each of those documents to each elector;
5. In accordance with the Blueberry River Custom Election By-law, 2017, I organized and facilitated a Nomination Meeting;
6. A copy of the Notice of Nomination Results is attached as Exhibit "C" to this Declaration;
7. A copy of the Notice of Election is attached as Exhibit "D" to this Declaration;
8. In accordance with the Blueberry River Custom Election By-law, 2017, I publicly posted the Notice of Election and Notice of Nomination Results, and I delivered copies of the Notice of Nomination Results and Notice of Election to each elector;
9. A copy of the Mail-in Ballot Package is attached as Exhibit "E" to this Declaration;
10. In accordance with the Blueberry River Custom Election By-law, 2017, I delivered a Mail-in Ballot Package to each elector who is not ordinarily resident on Reserve and to each elector from whom I received a request for a Mail-in Ballot Package;
11. I was responsible for overseeing all voting and for counting all ballots cast in Blueberry River Council Election;
12. The number of electors was 398 and their names are entered on the elector's list, which is attached as Exhibit "F" to this Declaration;
13. The results of the Vote are as follows:
  - (a) \_\_\_\_39\_\_\_\_ mail-in ballots were cast in the Council Election;
  - (b) \_\_\_\_110\_\_\_\_ regular ballots were cast in the Council Election;
  - (c) \_\_\_\_1\_\_\_\_ ballots were spoiled;
  - (d) \_\_\_\_0\_\_\_\_ ballots were rejected;
  - (e) \_\_\_\_0\_\_\_\_ ballots were cancelled;

(f) \_\_\_\_19\_\_\_\_ ballots were marked in favour of CHIPESIA, Simone, who I declared elected for the position of the Late Daniel Apsassin Family Councillor;

(g) \_\_\_\_34\_\_\_\_ ballots were marked in favour of CROSSLEY, Dan, who I declared elected for the position of the Late Edward Apsassin Family Councillor;

(h) \_\_\_\_21\_\_\_\_ ballots were marked in favour of DAVIS, Jared, who I declared elected for the position of the Late Pete Davis Family Councillor;

(i) Troy Wolf was acclaimed and thus I declared them elected for the position of the Late Jack Wolf Family Councillor;

(j) Georgina Yahey was acclaimed and thus I declared them elected for the position of the Late Charlie Yahey & Jack Appaw Family Councillor;
